Monograph

Provisional title: "Caste Reinvented: Arains, Islam, and politics in twentieth century South Asia"

By tracing the political engagements of the Arains, a Punjabi Muslim community, my book will argue that caste played a key role in the Muslim politics of late colonial and early post-colonial South Asia. Caste, generally seen as a Hindu phenomenon, was a marked feature of the evolution of the Arains' identity and the community's emergence as a bounded, albeit ideologically heterogeneous,

political unit distinct from other South Asian Muslims.

Journal Articles

Provisional title: "The allure of Arab descent: genealogy and caste among diasporic Arains"

Interrogates the persistent pull of narratives of Arab-Muslim descent among diasporic Arains in the United Kingdom. Asks why and how Arains in the UK reconcile their purported Arab-Muslim self-imagination with their roots in the

Indian sub-continent as well as their British citizenship.

Provisional title: "Kashmir and the challenges of writing its history"

Offers a historiographical review of Kashmir to examine how competing claims about self-determination and the nationalist narratives of India and Pakistan

have shaped scholarly writing on the subject.

Hist 385-2: History of modern South Asia, 1750 to the present. Undergraduate lecture. Survey course on the history of South Asia from the mid-eighteenth century to the present. Topics covered include political transitions from Mughal to colonial and colonial to post-colonial rule; rise of anti-colonial nationalisms; social movements against gender and caste-based discriminations; social, legal, and economic changes.

Hist 300: South Asians in the World, 18th century to the present. Undergraduate lecture. Survey course on the history of South Asian migration from the eighteenth century to the present. Topics covered include the intertwining of imperial needs

Hist 393: Frontiers, Borderlands, Nationalisms. Undergraduate seminar. Bi-weekly seminar focused on the history and theory of borderlands and nationalisms in South, Central, and Eastern Asia, with brief forays into Eastern Europe and North America.

Hist 103: Islam, Gender, and the Modern World. First-year undergraduate seminar. First-year seminar on ideas of gender, religious practice, modernity, and colonialism in the 19th and 20th century Muslim world, with a special focus on colonial and post-colonial South Asia.

Weekly seminar examining the complexity of the Islamic tradition in South Asia by focusing on controversial gender issues from the eighteenth to the twentieth centuries. Topics include reformist education, Muslim women reformers, seclusion, polygamy, divorce, women's inheritance rights, women's franchise, and modes of political expression.
